

Presented above are the comparative balance sheets for the parish. The purpose of a balance sheet is to present the assets, liabilities and accumulated surplus of an organization, at a specific point in time. The difference between the parish's assets and liabilities represents the accumulated surplus, since the inception of the combined parishes on July 1, 2019.

As of June 30, 2022, the unrestricted cash available to the parish was approximately \$400,000. This reflects approximately five months of recurring operating expenses for the parish. The ideal level of cash on hand translates to six to nine months of operating expenses, as per Archdiocesan best practices. In addition, as the parish's infrastructure needs are addressed, future increases in repair and maintenance expense should be anticipated. The resources of our parish will receive ongoing review and assessment, to address operational and ministerial needs.

The next phase of RMC (Renew My Church) is Building the New Reality, with a focus on evangelization, to encourage a vibrant and thriving parish for future generations with sound financial stewardship.

On September 15, 2022, the parish closed on the sale of the convent building, receiving net proceeds of approximately \$185,700. The funds are on deposit at the Archdiocesan Bank, in the HGA Savings account.


